

Very positive interim conclusion after two and a half weeks in provisional insolvency proceedings: No redundancies planned



Kronach-Neuses. It is now just over two weeks since Dr. Schneider filed an insolvency petition for the German companies of the group with the Coburg District Court on 7 September 2022. The provisional insolvency administrator, lawyer loachim Exner from the law firm Dr. Beck und Partner, now draws a very positive interim conclusion from the provisional insolvency proceedings. Exner informs about the following key points:

- Wages and salaries were paid in full and as planned.
- **No dismissals of employees** are planned on the part of the insolvency administration.
- Current business operations have been stabilised; all obligations with regard to customers and suppliers will continue to be met.
- **ALL customers support** the Dr. Schneider Unternehmensgruppe worldwide and **provide sufficient liquid funds** for the continuation of ongoing business operations.
- The main customers have confirmed that they will continue to plan with the entire Dr. Schneider Unternehmensgruppe in the future and **need the company as a firm partner at their side**.
- The investor process will be driven forward in the coming weeks, and with the involvement of a strategic investor, Dr. Schneider's future will be bright. Concrete details can only be announced after a contract has been signed in order to protect the interests of the parties involved during the complex process.











Of course, the commitment of the entire workforce in all plants is essential for a positive future, and Exner has seen them highly motivated in the last two weeks despite the initially negative insolvency news.

The provisional insolvency administrator explains: "This is all very good news for the entire Dr. Schneider Unternehmensgruppe, we are on the very best path. We are very happy to have received so much support from our customers, so that the innovative strength of the company can be maintained. We are looking to a positive future for all of the group's locations - our customers have clearly signalled to us that they do not want to imagine an automotive supplier world without Dr. Schneider. There could not have been a better future perspective for us at this point in time".
